Encroachment Permit Application

Instructions:

1. Applications must be completed and signed by the applicant.
2. Person conducting the work has marked (white paint) the location of the work and makes a BUD request in compliance with the KY 811 program.
3. Once the work and all applicable utilities are marked the applicant will contact the Engineering Department for the construction inspector and applicable city utility departments to make a site visit prior to construction.
4. If necessary, adjustments are made to the drawings as required. Bond amount and insurance requirements are determined. Drawings should include:
 - Plan view showing: alignment, proposed structures (shape, dimensions, and locations), and offsets.
 - Profile view showing proposed depth and any known structures
 - Known utilities including stormwater conveyance structures
 - North arrow and reference streets or land marks.
5. Applicant submits any necessary bonds and/or insurance certificates as applicable for non-franchised utilities.
6. **Encroachment Permit Issued** by City Engineering Department with applicable conditions.

7. Applicant contacts the city for a backfill and close out inspection. Including:
 - As built construction with planned construction. Notes variations on the plans.
 - Inspects back fill operations are in compliance with applicable standard detail or approved alternative for trenching under roads and sidewalk surfaces.
 - Checks final site stabilization (vegetative cover is growing, drainage paths are functional.)
8. Bond is released and Permit closed out.
